Payment

We do not apply for the permits until a £360 deposit has been paid.

The full balance needs to be paid 7 days before departure date.

If using our permit service only the full amount for the permits need to be paid.

We also offer a collection/ Storage service from Wimbledon to the port.

1. Collection from our yard costs £150, your vehicle will need to be at our yard 8 days before your shipping date.
2. Storage at our yard in Wimbledon is charged at £50 per week, if you are using our collection service this fee does not apply.

Please send the following documents with this form

1. Colour copy of V5 registration certificate for the vehicle (only page two with the vehicle details). If you have owned the car from new I will also need page one. For Japan imports I will also need page one. For Japan imports please make sure that the engine number and vehicle model is stated and correct, this causes major problems if incorrect or not present.
2. South African Citizens - Colour copy of S.A. passport / ID book (Only the photo page please), and colour copy of your British passport if you have one. For citizens with indefinite leave to remain please **do not** send us copies of the indefinite leave to remain stamp as we do not need this.
3. British Citizens- Colour copy of British passport (photo page only) and your South African permanent residency permit.
4. EEC Certificate. This only applies to cars manufactured from 1997 – 2004 that **do not** have E type approval number on the V5. Please check section (4)k (Type approval no.) on your logbook for this. To obtain the EEC you must contact the vehicle manufacturer head office not your local dealer.
5. Work Reference. This must prove that you have worked in the U.K. for the same period that you have owned your vehicle. If you changed employers you will need to get references from your old employer to. It must have the date you started work and the date you are ending your employment. The letter must also be dated with the date it is written. If it is missing one of these dates your application will be denied. It must also be on a company letter head.
